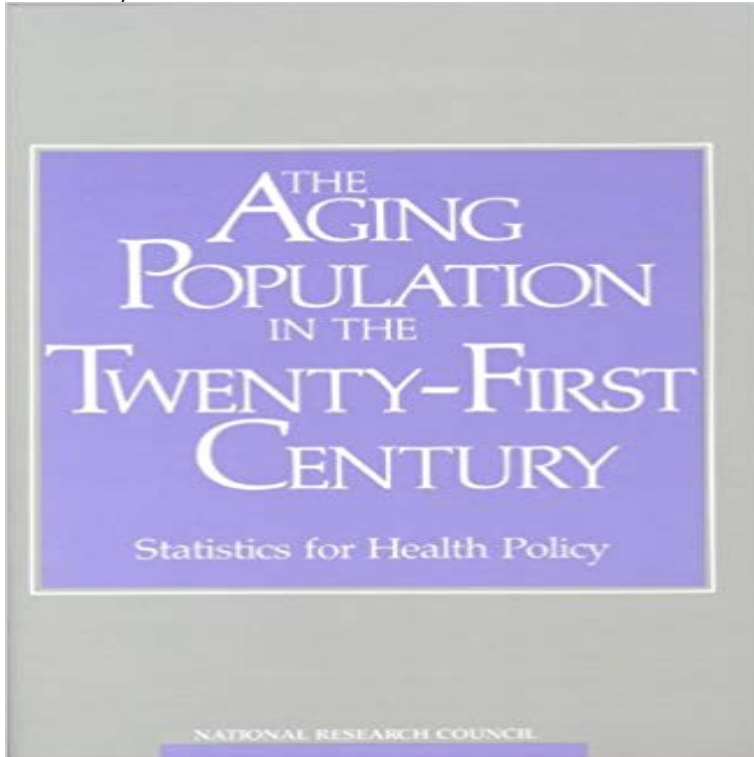


# The Aging Population in the Twenty-First Century: Statistics for Health Policy
