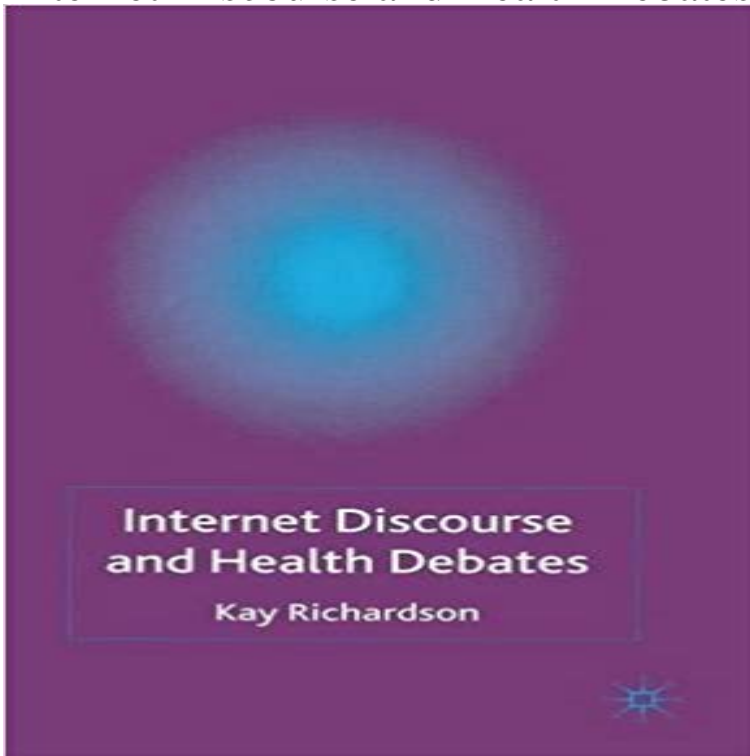


# Internet Discourse and Health Debates
