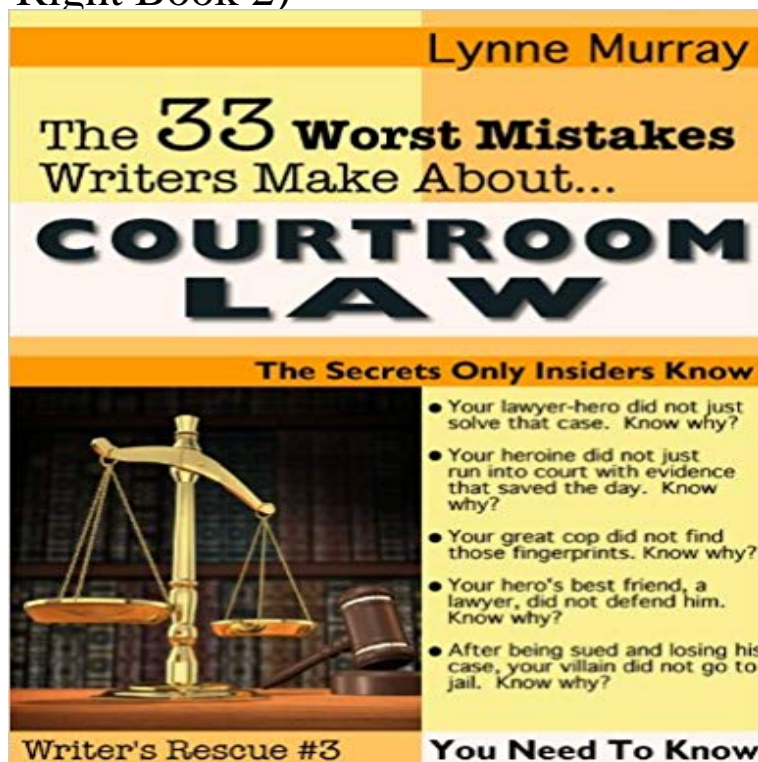


The 33 Worst Mistakes Writers Make About Courtroom Law (Write It Right Book 2)

Law is all about conflict and a little research can yield some great plot ammunition, while blithely committing the worst blunders about the law that can get popcorn thrown at the screen or your book thrown across the room by otherwise mild-mannered lawyers and paralegals.
