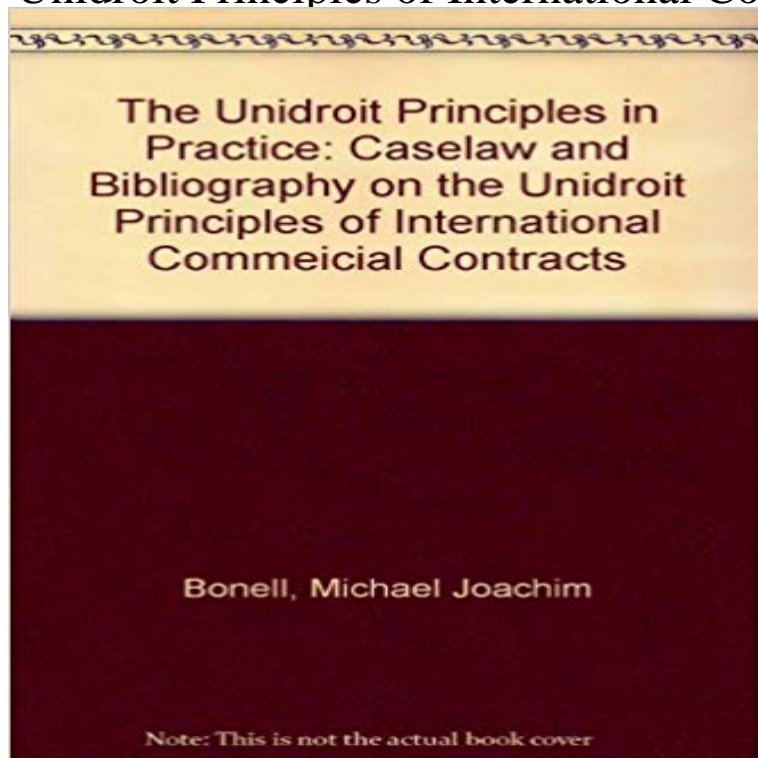

They are widely recognized as a balanced set of rules designed for use throughout the world irrespective of the legal traditions and the economic and political conditions of the countries in which they are applied. A large number of States have already taken the Principles as a source of inspiration in their law reform projects. Business persons increasingly rely on them to negotiate and draft international contracts. Arbitrators and judges more and more frequently resort to them to settle transnational commercial disputes.
